AFTER Stage 2



- 1. **Correction:** The Stage 1 finish time for #81 SITLER Jake (CCB Foundation) is corrected to 4:40:19, inside of the time cut.
- 2. Time Cut: The time cut for Stage 2 was 39:45. No riders were time cut.
- 3. **Points Classification:** A Stage 3 Time Trial win will not count towards a secondary tie breaker for the Points Classification.

4. Time Trial Reminder:

- The bike measurement jig will be available for unofficial pre-race bike checks at 7:45 AM before stage 3. Final checks before will begin at 10:10 AM.
- Riders must stay to the right of the center lane at all times- riders may be returning downhill after finishing.
- No team cars will be allowed to follow riders on course for the TT
- Stationary support is allowed, but vehicles may not move until the last rider has finished.
- Teams wishing to support their riders from a stationary position on course or go to the finish must depart for the course before the first rider starts. They cannot return until the after the last rider finishes.
